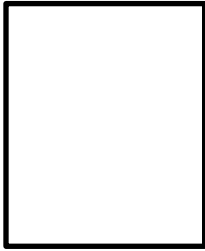

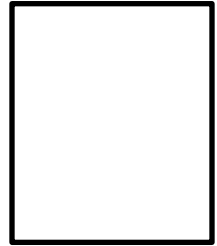

Mandatory requirements to get approval:

1. Vaccine record of the horse.
2. Minimum stable size 12sqft x 12sqft with the roof as per PCA 1960.
3. Nutritious food and water to be provided at all times
4. Rust free and clean bridle and bits to be owned. To be verified by AH Dept. frequently.

5. The horse should not have any injuries and needs a fitness certificate from a Veterinary doctor every 6 months.

Declarations by Animal owner:

1. I will take care of my animal with best interests in mind.
2. I will not use the animal between 10 am to 4 pm due with extreme heat/harsh weather.
3. I will ensure the animal is vaccinated and receive periodic veterinary care and treatment.
4. I will scoop the feces and dispose of them in a designated place.
5. I will not employ any jockey below 18 years of age.
6. I will not use the animal beyond 20-21 years of age, depending on its health and the care provided
7. I will not use the animal after 6th month of pregnancy and resume use after 3 months' post delivery
8. I will comply with the law of the land. If any of the laws are violated I am subjected to action by Law enforcement authorities.
9. I understand that if any of the above declarations are violated, the animal can be seized by the authorities.
10. The animal owner may face a permanent prohibition from owning equines depending on the severity of the offense.
11. A warning may be issued, and if there is no compliance, the equine may be seized immediately.
12. I will not sell/ transfer the equine in my ownership without the prior permission of the Tamil Nadu Animal Welfare Board.
13. I will Inform the Tamil Nadu Animal Welfare Board in the event of death / fatal injury of the equine in my ownership.
14. I am fully aware that only those equine registered / Microchipped by the Tamil Nadu Animal Welfare Board can be used for joyrides / marriages or / and any other / all purpose – when used for a monetary gain.
